PROCEDURE:

C. NEW REGISTRATION:

- Go to the website www.pusra.gkp.pk.
- Click on the **Registration Menu**.
- Click on the **Apply for user name & Password** option. After filling the requisite information's in the form submit it. After submission of the form, the proposed **user name and password** will be activated.
- After activation of user name and password, click on the **Apply Online** → Private Schools.
- Enter user name and password in the window and click **Login**.
- Enter school data in the forms one by one.
- After filling the Registration Form, get a print and attach all the required documents along-with required fee challan deposited into Account No. 07331-00-2 in any branch of the Bank of Khyber in Khyber Pakhtunkhwa and then submit the registration form complete in all respect in the office of KP-PSRA House No. 18-E, Syed Jamal Ud Din Afghani Road, University Town, Peshawar.

Note: If made any wrong entry then do not click back. At the end of submission of all data, Edit /Delete / Add option are available.

D. RENEWAL OF REGISTRATION:

- Click on **Apply Online**. Enter the already allotted User Name and Password in the window.
- After the above, you will get **Edit** option for your previously entered data for the Current Session.
