SUBJECT: Request for Cooperation of Private Schools in the Upcoming Polio Campaign (26th May - 1st June 2025)

Reference to the subject cited above that poliomyelitis remains a serious public health concern in Pakistan, and the involvement of the education sector is crucial to eradication efforts. With the upcoming National Immunization Days (26 May – 1 June 2025), the District Administration seeks support from private schools, as polio teams face difficulties accessing eligible children enrolled there.

In this regard, you are requested to kindly direct all private schools under your jurisdiction to:

- 1) Extend full cooperation to their respective Union Council Polio Officers and polio teams.
- Provide the list of children under 5 years of age, in the prescribed format shared by UC Polio Officers / Area Supervisors/ Polio teams. (Prescribe format is hereby attached)
- 3) Facilitate campaign phases including micro-census, microplanning, and intracampaign vaccination.
- 4) Ensure timely communication with parents regarding campaign dates to avoid delays in vaccination.

The Polio Campaign's success relies on strong coordination between schools and polio workers to ensure every eligible child is vaccinated. Your continued support and prompt action in guiding private schools are appreciated.
