Subject: MINUTES OF MEETING ON REVIVAL OF SPORTS IN SCHOOLS ACROSS PAKISTAN

A meeting on the subject was convened in the Ministry of Inter Provincial Coordination with relevant stakeholders under the chairmanship of Rana Sanaullah Khan, Minster for Inter Provincial Coordination at 1400 Hours on 24.05.2024 in the committee room of Ministry of IPC, 2nd Floor, Kohsar Complex. The list of participants is at **Annex-I**.

Discussion Points

2. The meeting commenced with the recitation of a few verses from the Holy Quran. The chair welcomed the participants and asked the Secretary, IPC to open the discussion. The Secretary IPC first invited all the participants to introduce themselves. Thereafter, he explained that sports was once an integral part of studies but now it has dimlnIshed. Therefore, we must take all the steps to revive sports in schools which are nurseries for the development of sportsmen of national and international caliber. The Chair was of the view that in order to make a meaningful intervention in this regard it is imperative that the IPC first collects necessary data, evaluate the same and see where do we stand today. Thereafter the provinces were asked to set and share realistic targets. The Role of IPC should be that of extending technical and financial support to the provinces. However, as an advice to the provinces and Federal Government, the chair suggested to incentive the performance in sports for the headmasters/principals. It was also suggested that the Federal government should first focus on the lagging districts around the country to ensure prudent utilization of resources.

Next Steps/Decision

- i. The next meeting should be held within one month;
- ii. Data from all the educational institutions around the country be collected;
- iii. "Minimum sports facilities" may be defined and the provinces be asked to inform that how many schools have these facilities;
- iv. Each province shall set a realistic target and make a proposal to the federal government for technical and financial assistance. The said assistance shall be based on the performance of the province concerned in the field of revival of sports in schools;
- v. IPC shall create a demand and submit to Finance Division for allocation of budget;
- vi. Secretary IPC may hold a meeting within 15 days to see where we stand for the scheduled meeting after a month;
