01	Carbonated soft drinks, energy drinks, papad and coloured, Flavored Chips	Restricted in Schools & collages
02	Gutka, Pan, Chaalia and Chorin	Banned
03	Monosodium Glutamate (MSG)	Banned
04	Substandard Ice-cream/ Dessert etc. (Which contain non-food grade colours, flavors or any other health hazardous ingredients.)	Banned
05	Slaughtering of small animals	Banned
06	Sale of Loose spices	One-year grace period granted
07	Calcium carbide as fruits ripening source	Two years grace period granted
09	Mislabeling	Followed as per PSQCA standards. e.g it should be clearly mention on the tea whitner. "ye Dodh nai hai"
