PROCEDURE:

HOW TO APPLY FOR RENEWAL OR UPGRADATION FOR SESSION 2025-26:

1. Go to the website www.psra.gkp.pk/institute/login.
2. Enter your **Username** and **Password** on the login page.
3. Click on "**Login**" to access your dashboard.
4. Once you're logged in, click on the "**Apply for Renewal or Renewal + Upgradation** (whichever is applicable) for the session 2025-26" button.
5. Complete sections **B, C, D, E, F, G, H** and **I** in the form. the next section will be available once the previous section has been filled out.
6. Once all sections are completed, the system will generate a fee challan for Renewal or Upgradation based on the information you entered.
7. Deposit the system-generated Bank Slip at any Branch of Bank of Khyber in the KP province.
8. Once you've deposited your fee, enter the STAN and Date on the receipt provided by Khyber Bank on the online portal and submit your application online.
9. Your renewal or upgradation certificate will be sent to you online after the official formalities have been completed.
10. In case of any deficiency, the same will be communicated to your school through your school online portal and you can check the status of your application on your dashboard which will be updated regularly.

HOW TO APPLY FOR INSTITUTE REGISTRATION WITH PSRA:

1. Go to the website www.psra.gkp.pk/institute/login.
2. Click on the **Create Institute Account**.
3. After creating institute account page, Enter Account Username, Account Password, Confirm Password and Email Address and click on **"Create Account"**.
4. After Account created Enter Username and Password and Click on **"login"**.
5. Once you're logged in, enter **institute detail** and click on **Save and Continue**.
6. On Dashboard click on **"Apply for registration"**.
7. Complete sections **B, C, D, E, F, G, H** and **I** of the form. The next section will be available once the previous section has been filled out. Once all sections are completed, the system will generate a fee challan for new registration based on the information you entered.
8. Deposit the system-generated Bank Slip at any Bank of Khyber Branch in the province. Once you've deposited your fee, enter the STAN and Date on the receipt provided by Khyber Bank on the online portal and **"Submit"** your application online.
9. Your registration certificate will be sent to you online after the official formalities have been completed.
10. In case of any deficiency, the same will be communicated to your school through your school online portal and you can check the status of your application on your dashboard which will be updated regularly.

Owners of all those private schools whose previous renewals i.e. session 2018-19, 2019-20, 2020-21, 2021-22, 2022-23, 2023-24 and 2024-25 are still pending are hereby directed to clear their dues/cases immediately otherwise strict action will be initiated under KP-PSRA Act, 2017 and Regulations, 2018.
